Sixty-ninth year**Letter dated 9 May 2014 from the Permanent Representative of
Cyprus to the United Nations addressed to the Secretary-General**

Upon instructions from my Government, I enclose herewith two separate annexes recording the infringements of international air traffic regulations and violations of the national airspace of the Republic of Cyprus by Turkey (see annex I), and the illegal use of closed ports by Turkish warships (see annex II) during the month of March 2014. It should also be noted that Turkish commercial aircraft systematically use the illegal Timpou airport. I have the honour to draw your attention to the systematic infringements by Turkey of the sovereignty and territorial integrity of the Republic of Cyprus through blatant violations of international law, in a way that seriously jeopardizes safety and security in the greater region.

I would be grateful if you would have the present letter and its annexes circulated as a document of the General Assembly, under agenda item 42, and of the Security Council.

11-13 March 2014	One A-1600 Turkish military transport ferry violated the territorial waters of the Republic of Cyprus and illegally used the closed port of Ammochostos.
18-19 March 2014	One F-505 Turkish corvette violated the territorial waters of the Republic of Cyprus and illegally used the closed port of Ammochostos, while participating in naval exercises of the occupation forces.
22-24 March 2014	One F-244 Turkish frigate violated the territorial waters of the Republic of Cyprus and illegally used the closed port of Ammochostos, while participating in naval exercises of the occupation forces.
